**ELIGIBILITY** Eligible two dimensional media include painting, drawing, printmaking, pastel and mixed media. **Sculpture, photography and digital art are not eligible.** Work may not exceed 36" in height or width, not including frame. Bowery accepts applications from outside the U.S.

**SALES** All work will be for sale unless the artist informs the gallery to the contrary. All proceeds from sales will go to the artist.

**FEES** \$35.00 entry fee allows each artist to submit 1-3 images. Additional images may be submitted for an extra \$6.00 per image. Maximum submission: 6 images. Entry fees are paid through the entry form's Paypal link, which accepts credit cards.

**SUBMISSION** Work will be juried from images submitted only through the gallery's online submission form accessible at: [www.bowerygallery.org/juried.html](http://www.bowerygallery.org/juried.html). Images must be JPGs with minimum width/height of 500px, maximum size 3MB. Please do not use spaces or special characters (such as @/!"(:#;%)&\$) in image file names. An embedded color profile is recommended for accurate color.

**DEADLINE** All applications must be submitted before midnight on April 20, 2021. Bowery Gallery will make every effort to notify all applicants of juror's decision by June 1, 2021.
