31st Annual Juried Competition *Lance Esplund, Juror*

AUGUST 2-20, 2022

Lance Esplund will be the juror for Bowery Gallery's 31st annual juried competition. Over its 53-year history, exhibitions at Bowery Gallery have been reviewed in The New York Times, The New York Sun, The New Republic, Art in America and many other publications. The opening reception will be held 5-8pm on Thursday, August 4.

All selected works will be hung in a physical exhibition in the gallery's space in Chelsea, NYC. In the unlikely event of a Covid-necessitated shutdown, artworks will be presented in an online virtual exhibition.

Lance Esplund

is an art critic for The Wall Street Journal and author of The Art of Looking: How to Read Modern and Contemporary Art. Previously, he was U.S. art critic for Bloomberg News, chief art critic for The New York Sun, and editorial board member and New York correspondent for Modern Painters. He has taught at the Parsons School of Design, Rider University, and Queens College (CUNY), and has served as a Pulitzer Prize juror and as visiting MFA critic at the New York Studio School. His essays have appeared in Air Mail, Art in America, Art & Antiques, The Atlantic, Disegno, Harper's, The New Criterion, The New Republic, The New York Observer, The Threepenny Review, The Weekly Standard, and The Yale Review, among other publications.

ELIGIBILITY Eligible two dimensional media include painting, drawing, printmaking, pastel and mixed media. **Sculpture, photography and digital art are not eligible.** Work may not exceed 36" in height or width, not including frame. Bowery accepts applications from outside the U.S.

SALES All work will be for sale unless the artist informs the gallery to the contrary. All proceeds from sales will go to the artist.

FEES \$35.00 entry fee allows each artist to submit 1-3 images. Additional images may be submitted for an extra \$6.00 per image. Maximum submission: 6 images. Entry fees are paid through the entry form's Paypal link, which accepts credit cards.

SUBMISSION Work will be juried from images submitted only through the gallery's online submission form accessible at: www.bowerygallery.org/juried.html. Images must be JPGs with minimum width/height of 1000px, maximum size 3MB. Please do not use spaces or special characters (such as @/!"(:#;%&\$) in image file names. An embedded color profile is recommended for accurate color.

DEADLINE All applications must be submitted before midnight on April 20, 2022. Bowery Gallery will make every effort to notify all applicants of juror's decision by June 1, 2022.
